APPROPRIATION ORDINANCE (I)
NO. 2022- 34

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from the Collectors Automation Fund No. 3001:

To: 3001-0104-2001: Collectors Automation; Supplies; General Supplies	\$5,000.00
To: 3001-0104-3100: Collectors Automation; OS&C; Other Miscellaneous	\$20,000.00
To: 3001-0104-3009: Collectors Automation; OS&C; Other Professional Services	\$35,000.00
To: 3001-0104-4004: Collectors Automation; Capital Outlays; Machinery & Equipment	\$65,000.00

TOTAL: **\$125,000.00**

(This sum, \$125,000.00, is being moved from the Collectors Automation Fund into specific line items to pay for the anticipated moving expenses of relocating the office to the new county building.)

Section 2. If any provision or section of this Ordinance is held invalid by a Court of Competent Jurisdiction, such invalidity shall not affect other provisions and sections of the Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 3. This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.
