






We, the duly commissioned and acting Election Commissioners of Boone County, Arkansas, do hereby certify that the following is a true and correct abstract of votes cast in the Special Election held in the Town of Alpena, Arkansas (the "Town"), on the 12th day of September, 2017.

The results of the vote upon the questions submitted are as follows:

ORDINANCE NO. 262

AN ORDINANCE AMENDING ORDINANCE NO. 242 IN ORDER TO CHANGE THE DESIGNATED USES OF THE 1% SALES AND USE TAX WITHIN THE TOWN OF ALPENA, ARKANSAS LEVIED THEREBY TO (A) PAY AND SECURE THE REPAYMENT OF BONDS APPROVED BY THE VOTERS AND ISSUED BY THE TOWN FROM TIME TO TIME, AND ALL OBLIGATIONS OF THE TOWN WITH RESPECT THERETO, AND/OR (B) FINANCE GENERAL OPERATIONS OF THE TOWN AND OTHER PURPOSES OF MUNICIPAL GOVERNMENT; AND PRESCRIBING OTHER MATTERS RELATING THERETO.

SEWER SYSTEM BONDS

An issue of bonds of the Town of Alpena in one or more series from time to time in the maximum aggregate principal amount of \$1,500,000 for the purpose of financing a portion of the costs of acquiring, constructing, and equipping a sewer system and, in order to pay the bonds, (a) the pledge as collateral of collections from a 1% local sales and use tax levied within the Town by Ordinance No. 242, adopted October 4, 2005, as it may be amended from time to time (the "Tax"), and (b) the pledge of revenues derived from the operation of the Town's sewer system. Collections of the Tax not necessary to pay bonds will be used for other lawful purposes. If the bonds are approved, the Town may, prior to the issuance of the bonds, obtain interim financing as permitted by Arkansas law.
