

## APPROPRIATION ORDINANCE (1) ORDINANCE NO.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2020 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS;

SECTION 1. The following appropriation shall be made from County General Fund No. 1000:

TO: 1000-0400-1010: Sheriff; Personnel Services; Workers Comp	\$158.90

(These funds (\$10,707.89) were received on June 18, 2020 from the Department of Justice to reimburse Personnel Services for overtime paid for security of COVID testing sites. There are no new funds requested.)
