APPROPRIATION ORDINANCE (2)
 NO. 2022- 4

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

Section 1. The following appropriation shall be made from County General Fund No. 1000:

To: 1000-0400-1001: Sheriff's Office; Personal Services; Salaries, Full-Time	\$6,264.00
To: 1000-0400-1006: Sheriff's Office; Personal Services; Social Security Matching	\$480.00
To: 1000-0400-1007: Sheriff's Office; Personal Services; Retirement Matching	\$960.00
To: 1000-0400-1010: Sheriff's Office; Personal Services; Workers Compensation	\$104.00
To: 1000-0409-1004: District Court; Personal Services; Contract Labor	\$9,930.00
SECTION TOTAL:	\$17,738.00

(This sum, \$17,738.00, is to correct errors on the 2022 Annual Budget. This is for 3 Bailiff positions which should reflect a \$2.00 an hour increase with a corrected annual salary of \$33,320.78 and District Court Contract Labor should reflect a corrected amount of \$30,457.50.)

Section 2. The following appropriation shall be made from County Jail Operations Fund 3498:

To: 3498-0418-1001: County Jail Operations; Personal Services; Salaries- Full-Time	\$2,088.00
To: 3498-0418-1006: County Jail Operations; Personal Services; Social Security Matching	\$160.00
To: 3498-0418-1007: County Jail Operations; Personal Services; Retirement Matching	\$320.00
To: 3498-0418-1010: County Jail Operations; Personal Services; Workers Compensation	\$35.00
SECTION TOTAL:	\$2,603.00

(This sum, \$2,603.00, is to correct an error on the 2022 Annual Budget for one 1 Maintenance/Transport Officer. The budget should reflect a \$2.00 an hour increase with a corrected annual salary of \$35,579.36.)

GRAND TOTAL: **\$20,341.00**


