APPROPRIATION ORDINANCE (1)

NO. 2022- 23

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2022 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF BOONE COUNTY, ARKANSAS:

**Section 1.** The following appropriation shall be made from 911 Fund No. 3020:

From: 3020 – 911 Fund	\$27,496.02
To: 3020-0501-1001: 911; Personal Services; Salaries, Full-time	\$20,491.60
To: 3020-0501-1006: 911; Personal Services; Social Security Matching	\$1,435.20
To: 3020-0501-1007: 911; Personal Services; Retirement Matching	\$2,963.00
To: 3020-0501-1009: 911; Personal Services; Health Insurance Matching	\$2,206.60
To: 3020-0501-1010: 911; Personal Services; Worker’s Compensation	\$338.08
To: 3020-0501-1011: 911; Personal Services; Unemployment Contribution	\$61.54

(This sum, \$27,496.02, is funds received from the City of Harrison for salaries and benefits cost for the three HPD dispatchers paid from the 911 budget during the 1st Quarter, 2022. Pay included through March 31<sup>st</sup>, 2022, payroll. No new money appropriated.)

**Section 2.** If any provision or section of this Ordinance is held invalid by a Court of Competent Jurisdiction, such invalidity shall not affect other provisions and sections of the Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

**Section 3.** This Ordinance herein enacted is an Appropriation Ordinance and therefore It is effective immediately.

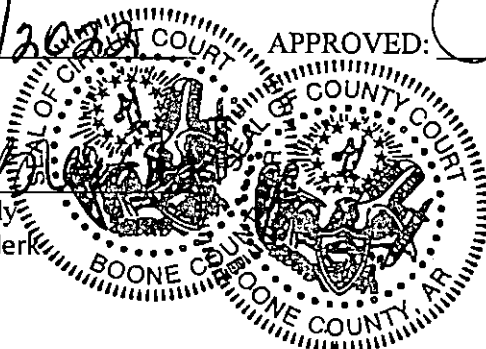
