Adoption of a 0.25% local sales and use tax within Boone County for a period of ten (10) years, the net collections of which remaining after deduction of the administrative charges of the State of Arkansas and required rebates, will be distributed only to the County and used (a) to acquire, construct, improve, renovate, expand, equip, furnish, operate and maintain criminal justice facilities, including any necessary land and acquisition and utility, road and parking improvements related thereto or in support thereof and (b) for other criminal justice purposes. If approved, the levy of the tax will commence on January 1, 2017.
