APPROPRIATION ORDINANCE (1)

No. 2024 - 36

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2024 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

Section 1. The following appropriation shall be made from the County General Fund No. 1000:

To: 1000-0400-1005: Sheriff's Dept; Personal Services; Overtime	\$9,084.09
To: 1000-0400-1006: Sheriff's Dept; Personal Services; Social Security Matching	\$694.93
To: 1000-0400-1007: Sheriff's Dept; Personal Services; Retirement Matching	\$1,391.68
To: 1000-0400-1010: Sheriff's Dept; Personal Services; Worker's Compensation	\$169.07

(The total of \$9,083.30, is money received from the Federal Bureau of Investigations as reimbursement for overtime hours worked by Deputy Dayton Evans in June, July & August 2024. The difference of \$2,256.47 will be new money to cover benefits paid for the overtime hours worked. Only overtime wages are reimbursed per the agreement with the FBI and the Sheriff's Office.)

Section 2. The following appropriation shall be made from the County General Fund No. 1000:

To: 1000-0400-1010; Sheriff's Dept; Personal Services; Worker's Compensation	\$41.79
To: 3034-0400-1005: Cops in School; Personal Services; Overtime	\$958.05
To: 3034-0400-1006: Cops in School; Personal Services; Social Security Matching	\$73.29

To: 3034-0400-1007: Cops in School; Personal Services; Retirement Matching \$146.77
To: 3034-0400-1010: Cops in School; Personal Services; Worker's Compensation \$17.83

(This sum, \$3,576.70, is money received from the Arkansas State Police as reimbursement for the Selective Traffic Enforcement Program (STEP) overtime worked in April 2024. The difference of \$422.27 will be new money to cover benefits paid for the overtime hours worked. Only overtime wages are reimbursed per the agreement with the ASP and the Sheriff's Office. Payment has been received and needs to be appropriated back to the original line items in the Sheriff's Dept. and Cops in School budget where the overtime and benefits were initially paid from.)

Section 3. If any provision or section of the Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

Section 4. This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.

In accordance with the requirements of Ark. Code Ann. 14-14-116, this publication is paid for from the budget of the Boone County Quorum Court. The total cost of this publication is _____.
