

APPROPRIATION ORDINANCE (3)

No. 2025 - 5

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO ESTABLISH A FUND TO BE CALLED GRANDMA'S HOUSE GRANT 2025 AND AMENDING THE ANNUAL BUDGET FOR BOONE COUNTY, FOR THE FISCAL YEAR 2025 AND AUTHORIZING THE COUNTY JUDGE TO ADMINISTER SUCH BUDGET AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF BOONE, STATE OF ARKANSAS:

<u>Section 1.</u> It comes before this Court that there is a need to establish a fund on the books to track the revenues, expenditures and/or appropriated transfers of funds for the Grandma's House Children's Advocacy Center received from the Arkansas Economic Development Commission through the Community and Economic Development Program. This Court recognizes and affirms the need for such a fund to properly account for and control all such revenues received and expenditures made in compliance with all applicable laws.

<u>Section 2.</u> There is hereby created on the books of the Boone County Treasurer and the books of the Boone County Clerk a fund to be known as the Grandma's House Grant 2025 Fund with a fund number of 6403 as assigned by Arkansas Legislative Audit.

<u>Section 3.</u> The Federal Award ID for this grant is B-20-DC-05-0001 with a Grant Control number of 790-09300-20 and CFDA number of 14.228. The grant amount totals \$522,714.00 received from the Arkansas Economic Development Commission as the grantor. These funds will be direct deposited to Boone County in a non-interest bearing account and Boone County will administer the payments for the project.

Section 4. The following appropriation shall be made from the Grandma's House Grant Fund No. 6403:

Appropriation Ordinance (No. 3) Establishing Grandma's House Grant 2025 Fund <u>Section 5</u>. The project includes renovation and expansion of Grandma's House Children's Advocacy Center in Harrison, which serves families in Boone County. Renovations to the building will include ADA accessibility to the restroom, new flooring, electrical upgrades, and installation of HVAC systems. Construction will include a new covered entryway, forensic interview room, observation room, two offices, additional storage space, and installation of new water line into the building.

<u>Section 6.</u> If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared to be severable.

<u>Section 7.</u> This Ordinance herein enacted is an Appropriation Ordinance and therefore, it is effective immediately.
